Re: Manitoba Hydro International

Manitoba Hydro International's (MHI) contract with the Board of Commissioners of Newfoundland and Labrador (Board) signed on 4 July 2011, has been completed and no further work is expected from the Board.

Subsequent to the release of the Board's report, MHI has been approached by the Government of Newfoundland and Labrador to potentially provide consulting services regarding the proposed generation projects in Newfoundland and Labrador, on a go forward basis. At present, there is no contract between MHI and the Government of Newfoundland and Labrador. Any contractual engagement with a third party on a related study may be construed as a conflict of interest with the Board.

MHI requests the permission from the Board to enter into an agreement with the Government of Newfoundland and Labrador or other third parties to carry on with the related study. At this early stage, MHI cannot provide significant details regarding the potential engagement.

As time is of the essence, MHI requests that a written response to this request be received by the close of business Monday April 9th, 2012.

MHI has greatly enjoyed working with the Board and their project staff on the two generation options report, and wishes the Board well in all its future endeavours.
