AGREEMENTS WITH THE INNU

Mr. Martin reported that the negotiations with the Innu on various agreements have in essence been finalized and the parties will be initialing the agreements in the very near future. He stated that there have been no material changes to the agreements from when the Board approved them at a previous meeting.
