Hi Danny,

The meeting with Charles, Paul and myself did clarify the expectations about the 800MW wind study case both from a technical and economic perspective. Due to time constraints the report on 800MW of wind will be more qualitative than quantitative. We need to "touch on" the technical issues of 800MW of wind using layman's terms. I already created a fairly complete list (from my perspective) of the technical issues that I can elaborate on in the report. We discussed many (but not all) of these technical issues at the meeting this morning and Charles was Ok with it. Dave Jacobson's summary will also be used here. We have to "create" an economic evaluation for the 800MW wind case. I have an idea on how to approach the economics and already discussed this with Rick Horocholyn (who happened to show up at the end of our meeting) and it will be better than a "back of the envelope" study but not an exhaustive costing analysis. We will develop our own data for the 800MW wind economics study (this is doable), but we will graciously accept any data that Nalcor can provide. Rick and I will work on this together. Nalcor will provide the economics to the Hatch study (300MW wind development case) and the stability study that they completed on the 300MW wind case. Our due diligence review of the Hatch report (300MW wind case) is still 50% or so of our deliverables. We do not need another meeting at this time, but perhaps mid next week after we receive the promised Nalcor reports noted above. Cheers.
