## AMENDING AGREEMENT

THIS AMENDING AGREEMENT NUMBER 3 is made as of the 13<sup>th</sup> day of January

## BETWEEN:

NALCOR ENERGY, a body corporate constituted pursuant to the Energy Corporation Act, S.N. 2007, c. E-11.01 and having its head office at the City of St. John's, Province of Newfoundland and Labrador, (hereinafter referred to as "Company") of the first part,

**SNC-LAVALIN INC.**, a body incorporated under the laws of Canada and having its head office in the City of Montreal, Province of Quebec (hereinafter referred to as "Consultant") of the second part.

WHEREAS an Agreement Number LC-G-002 entitled Engineering, Procurement and Construction Management (EPCM) Services (hereinafter called the "Agreement") dated 1<sup>st</sup> day of February, 2011 was entered into between Company and Consultant;

AND WHEREAS the parties wish to amend the Agreement as hereinafter set forth in this Amending Agreement.

NOW THEREFORE THIS AMENDING AGREEMENT WITNESSES that, in consideration of the premises and mutual covenants and agreements hereinafter set forth and contained, the parties hereto agree that the Agreement be amended as follows:

- In Exhibit 7 Project Milestone Schedule, Milestone 4, Muskrat Falls to Churchill Falls Transmission Interconnect – First 345kV HVac Transmission Line Ready for Power Transmission, is hereby deleted.
- This Amending Agreement shall be effective from the date hereof and shall remain in full force and effect from such date.
- This Amending Agreement is supplementary to the Agreement and is read with and construed in accordance with the Agreement, as if this Amending Agreement and the Agreement, as amended, constitute one (1) agreement.
