Hi Robert,

This might open up more issues that in it would solve.

Since Gull Island and any associated transmission is covered by the current exemption order, the industrial rates policy for Labrador may or may not include oversight by PUB for generation, and the province always has the authority to declare that things might be in or out of oversight, it might be cleaner for Nalcor to remain silent on what policy may be in this regard.
