Dear Premier:

Thank you for your letter of February 8, 2011, concerning federal support for the Muskrat Falls hydroelectric project, and your province's interest in acquiring the Government of Canada's ownership share in Hibernia. I appreciated the opportunity to discuss these issues with you during our meeting in St. John's on February 11.

I understand the importance your government attaches to the development of Lower Churchill, and the economic and environmental benefits you foresee for Newfoundland and Labrador and the Atlantic Region.

The Government will give your request for a loan guarantee careful consideration. As I explained during our meeting, the necessary due diligence will require further information on the financial structure of the proposed transaction including the business case and an examination of both the economic viability of the project and its environmental benefits. The Government will also need to consider the broader financial and energy policy implications of providing loan guarantees, something it has not done for many years, including the precedential impact for other megaprojects.

The process we discussed for facilitating dialogue and information exchange regarding the Lower Churchill proposals has been put in place. Janice Charette, Associate Secretary to the Cabinet and Deputy Minister of Intergovernmental Affairs, and Ed Martin, President and Chief Executive Officer of Nalcor, have already had a number of discussions, including meetings most recently on February 23, 2011.

With respect to Hibernia, you have indicated an interest in refocusing discussions solely on Canada's 8.5 percent working interest. I will ask Minister Flaherty to re-engage with you on the basis of a revised proposal from the province.

I am forwarding a copy of our exchange of correspondence to the Honourable James Michael Flaherty, Minister of Finance, for his consideration and to the Honourable Peter Gordon MacKay, Minister of National Defence, the Honourable Tony Clement, Minister of Industry, the Honourable Josée Verner, Minister of Intergovernmental Affairs, President of the Queen's Privy Council for Canada and Minister for La Francophonie, and the Honourable Christian Paradis, Minister of Natural Resources, for their information.
