Recovery programming has been an extensive multi-partner undertaking. The recovery team in 2004 released a recovery plan which highlighted various, monitoring, research and stewardship needs for these caribou populations. A great deal of data was collected from collars and other sources including some survey flights and habitat analysis. The recovery team has been working on an updated plan which we hope to have completed this year. This plan will include some of the new information and updated Goals, objectives and actions for recovery. This plan will also provide a description of critical habitat for the animals based on the many years of collaring data we have.

Q3 more straightforward with respect to ensuring our obligations under the ESA are met, appropriate mitigations are identified and agreed by proponents under the EA process, recovery planning process is re-engaged with updated plan developed, etc.

While the recovery team and the wildlife division is working on the updated recovery plan guidelines for industry for sedentary caribou will be developed to outline appropriate mitigations and best management practices to be followed by proponents.

Individual land use proposals will be reviewed and evaluated through the various land use referral and Environmental Assessment processes – development of an internal review matrix (tied in with guidelines)

Recovery plan will provide guidance on what habitat should be protected. When an updated plan for caribou is released if it contains critical habitat the minister will have to provide an explanation on how it will be protected.

Province will be asked in the near future to help the federal government with the development of Range Plans for Labrador Boreal Woodland Caribou, as required under their Species at Risk Act Recovery Strategy.
