I find this quite frustrating for two reasons, 1) Astaldi's award is based on a very stringent process that gives a "relative" score compared to the other bidders, not compared to a fictional company who has done the perfect number of hydro jobs and 2) MWH had this bidders list ages ago, knew that we arrived at the list through rigorous elimination of 10's of companies but expressed no concern whatsoever until after we award. Too little, too late.
