Subject: RE: LCRP - Due diligence status call

I held a lengthy call with Jim Meaney at Nalcor. I clearly and with no lack of certainty delivered the messages from yesterday's call. They believe that they can tackle and answer the various issues and questions on a timely basis with a view to as complete as possible a mid-November report. I stress that that is my plan and the thing I have been controlling to since we determined the timing to closing would give us time to assess and deal with outstandings and issues with a report on that timing (but not after we must have a good report for then).

Here is the plan we developed:

1. Nalcor teams are meeting today and using our Outstanding chart (version sent yesterday) they are specifically attending to each of the “greens” and will provide specific answers over the next week (at this time they believe to all of them).

2. They will prepare specific and detailed presentations to address the 4 larger issues: Astaldi selection and your expressed concerns, Critical path – milestones- Project Controls and Project Schedule; contingency and hydrology. These will be prepared in package and presentation format. We will determine the best forum for delivery of these presentations.

3. Tuesday while they are in Toronto we will have specific topic status meetings – one of those will be an item by item review of the “greens”.

4. We will do a report finalization meeting at NL (where the backup is readily at hand) the next week to complete final deliveries and reviews and address any remaining issues for the report to allow all list minute issues to be addressed.

We can plan attendance but the current is for Pyper, Rey, Joe and/or Anoop to participate in these.
