I would say that overall the result was a positive one. There were four aspects of that

1 technical .....this is an IE concern and we responded to all questions and I see no outstanding problems

2 planning ....this is a concern of the IE and they displayed a lack of understanding of planning that was frankly embarrassing. I see no issues to wrap up any outstanding issues. This seems to be a matter of education of the IE team.

3 ASTALDI ... The IE is MWH and they are in my opinion conflicted in any views on ASTALDI because they have a dispute ongoing ...however Lance and Ron Power did a great job of putting our case forward and the Feds advisors Cassel Brock's lawyer/advisor told me she put no weight in what I E opinion.

4 cost .. Jason odd his usual excellent delivery of the facts and I understand that it was no issue

Bottom line is the Feds advisors clearly saw that the I E is not as knowledgeable as our team in all areas and they are fully supportive of our position and our PM abilities.

So I would say the result is very positive and the I E report conditions precedent is in the bag
