Hey gent,

Not trying to muddy the waters here but just wanted to shed some additional light on the subject. The ATCL adjustment was to compensate for the difference between straight time and the OT premiums for the work performed. Yes we kept the crews busy, but in this case they completed the work after end of shift; so there shouldn't be a "double-dip" on the hours.

Kumar and I discussed this one on-site the weekend before we shut down. I told him that the ATCL adjustment should be made for this CHR, and reminded him that the agreement during the dispute meeting was to process the change request as submitted. As John eluded to below, there was no detailed discussion at the meeting about including or not-including the ATCL adjustment. I even showed Kumar my notes from the meeting in my logbook that confirmed the CHR would be processed as is.

John / Mike – if you prefer to leave this one alone than I will back down of-course. It just seems that we are always compromising on the ATCL, the client is consistently looking for any means to limit or remove it from our change orders.
