Ron,

Confirming our discussion earlier this week, John, Faustina, Catherine and I have had a number of discussions regarding the issue of SLI personnel switching from employee status to consultant/contractor status. I also had a brief discussion with Jose Gillis of SLI.

We believe there will be a limited number of individuals who will opt to do this. Those that do will then be responsible for their own payroll burdens. These may be less than SLI's payroll burden but the difference will likely be marginal. They will also potentially be giving up a certain amount of employment security. The final consensus is that as long as the billing rate to Nalcor does not increase then we would approve a revised PAA for such individuals. In that regard, I also checked with Philip Bursey regarding similar situations where this has occurred with individuals working directly for Nalcor. In those cases, the position adopted by Nalcor was the same, i.e. as long as the billing rate to Nalcor did not increase, the change was approved.
