Thanks kindly for hosting our meeting yesterday and for allowing us the opportunity to understand your current challenges on the Lower Churchill project.

We are pleased to learn that the project is moving closer to an *integrated team* approach that will allow leading experts from several organizations the opportunity to contribute to its ultimate success. Based on our discussions, we believe that Hatch can provide technical assistance to the project to enable a greater *depth of experience* within your project delivery team.

As promised, here are some of the key points that I noted during our discussions. Please feel free to comment/correct:

• Ron will meet with SLI (Norman Bouchard – SLI Project Manager) to discuss Hatch's potential participation on the project.

- Ron to set up a meeting between Nalcor/Hatch/SLI to discuss a collaborative approach to resolving key resource issues and critical work packages for the project next week.
- Paul suggested that some overarching collaboration principles are discussed at this meeting to solidify how we all wish to cooperate on this project.
- Ron provided us with a number of secondment opportunities from both Nalcor (Owner's Team roles) and SLI (Project Delivery Roles). Hatch is looking for potential candidates for these roles now.

• Key to providing the right staff is to ensure that they are "capable and experienced" in project delivery.

• For some roles there isn't a need for a hydropower background (e.g. Project Engineer/Scope Leader, Procurement, P&C, etc.). These will be identified on a case-by-case basis.

• Ron indicated that 4 or 5 SLI work packages will be heading our way for consideration as they are on critical path.

• Hatch agreed to start work on a MSA for SLI (both secondment and services) and a separate secondment agreement with Nalcor. These will be drafted for review by the relevant party.

• Paul noted that Nalcor has engaged MWH for an *Independent* Engineer role, to ensure that there is no conflict in using Hatch services for the work envisioned above.
