Just a quick note to recap Gilbert's interview with VOXM this afternoon:

- question if Quebec companies are getting preference on contracts due to SNC Lavalin's role with the project. Gilbert clarified their role and advised that Nalcor ultimately makes procurement decisions for the project.
- asked about concerns with hiring local workers that have been raised recently. Gilbert acknowledged current employment numbers and that work - and employment - will continue to ramp up as construction progresses.
- asked about status of engineering for the project (more than 50 percent complete)
- questioned stability of the north spur at Muskrat Falls. Gilbert acknowledged significant investigation and feasibility work completed to date, no concerns from Nalcor re designs.
