Brian,

We realize you have been busy lately and hope your trip has gone well.

We were wondering, when you get a chance, if you could provide some comments on the Contractor's proposal (see email below from May-22) to use horizontal slip forming to form the upstream and downstream faces of the dam. Have you used it successfully in the past, or have you encountered any difficulties? Any cautionary notes you may have? Any experience with air entrainment and freeze-thaw durability? Concerns or experience around surface finish and tolerances?

Also, do you have example specifications for the concrete mix to be used for the slip -forming operation - since this operation is not part of the initial spec we will have to develop some guidelines for the product.

FYI, the shape of the downstream form presented in the execution plan has been discussed with the contractor and they have been informed that the slight batter on the exposed side of the form cannot be used, it must be either vertical or battered to match the slope of the dam. Vertical steps seems to be preferred at the moment. Thanks,
