LCP Objectives For CH0032 Spillway Scope

Ready for diversion 1-Jul-2016

- All Spillway scope does not need to be 100% complete to allow river diversion.
 - All gates and stoplogs must be operational they can be controlled from the hoist house, likely by temporary power supply
 - Gate heating systems, and spillway electrical building are not needed to be fully complete

Change in Schedule

Upstream Spillway Ready For Hydro-Mechanical Contractor

Delayed from 16-Feb-2015 to 1-Nov-2015

Ready for Diversion Delayed from 13-Feb-2016 to 1-Jul-2016

Original duration to complete full scope was 362 days. Most of the scope must now be completed in 243 days.



Andritz Acceleration Proposal

• LCP received AH draft acceleration proposal for the mechanical scope 18-Aug-2015.

• Mechanical scope is critical path and the majority of the manhours. (47,320 Mhrs)

• Civil and Electrical scopes to be part of a later proposal expected to be ready 31-Aug-2015



Andritz Acceleration Proposal

 Identifies a number of open commercial items that must be closed to start accelerated schedule and mobilize to site


Contains no detail on how the work will be executed

 Includes only high level one-page schedule with no reference to baseline



Proposal Summary

- Andritz draft proposal shows limited commitment on their part to meet the diversion timeline. Only incentive is \$1.5M bonus.
- Accelerations costs payable regardless: "The lump sum would be payable to the Contractor regardless of the actual completion dates of any of the works on the spillway."






Strategy for Counter Proposal

- Need Andritz to commit to the schedule for diversion
- Increase Andritz share of risk.
 - Include 2.5M bonus in ready for diversion bonus
 - Include some of acceleration costs in ready for diversion bonus
- Increase Incentive for Andritz
 - Increase bonus basic amount by 2.5M



Strategy for Counter Proposal

- Increase Incentive for Andritz
 - Increase bonus basic amount by 2.5M





Strategy for Counter Proposal

- Require a pre-estimate of costs associated with further delay to start date
- Closure of all unresolved commercial issues to this point in time for the spillway
