Guido,

The Early works Schedule has been developed based on the following assumptions:

- 1: Site conditions dates as per the LNTP attached document.
- 2: All contractor's responsibility permits as listed by the client were captured.
- 3: A 5 days calendar with NL statutory holidays has been used except for the Site conditions dates which used a 7 days calendar in order to respect the dates.
- 4: The Spillway Cover System will be installed prior to the final clean-up of the rock surface which will take place once the Cover is installed. This approach enables us to complete the installation of the Cover before the year end of 2013.
- 5: The Crushing & Screening system will be relocated to the Contractors' laydown area as soon as we have access and the aggregates production will resume and will go on until end of 2013.
- 6: The Existing Béton Provincial Batching Plant will be relocated at the Contractors' Laydown area as soon as the foundations are poured upon receipt of construction permit scheduled on 14 November 2013. The foundations will have to use the Goose Bay concrete supply. With this approach the Batching Plant, line 1 will be operational by end of January 2014.
- 7: The ICS system was based on Information given to us by Ken Chryssolor after, as I understood, he spoke to a potential supplier.

The date used for the completion of the design by Astaldi is November 6th, 2013 as per Jack Zhou.
