Contractor notifies hereby that as part of the global sale of the thermal power, renewable power and grid business of the Alstom group (the "Power and Grid Business") to General Electric which closed this 2nd day of November 2015, the control of Alstom and its affiliates which are part of the Power and Grid Business has been transferred to a legal entity controlled by General Electric Company. Completion of the global transaction was announced by a press release the same day.

Please be advised that Alstom Grid Canada / Alstom Réseau Canada has changed its corporate structure transitioning from an "Inc." company registered under the corporate laws of Quebec to an entity "ULC" (Unlimited Liability Corporation) registered under the laws of British Columbia, effective July 23rd, 2015. We will continue to operate under Alstom Grid Canada ULC / Alstom Réseau Canada ULC with the General Electric Company branding until the name is changed to GE Grid Solutions in the coming months.

These corporate changes are purely administrative and do, in no way, impact the ongoing contracts you have nor does it change your day to day relationship with Alstom.
