Hello Craig and Harman,

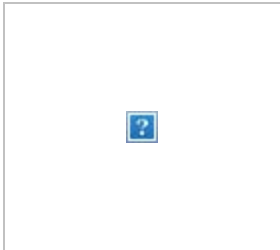
