Dear Mr. Bianchi,

Contractor's continued inability to provide compliant monthly progress reports in accordance with the Agreement is adversely affecting Company's ability to accurately report progress to its stakeholders and shareholders. The importance of timely, accurate, and compliant monthly reporting has been communicated to Contractor in numerous letters and meetings. To summarize, the current status of the monthly progress reports is as follows:

During the most recent mid-month coordination meeting held on 22-Sep-2016, Contractor advised Company that it would ignore comments made by Company on monthly progress reports, suggesting that Contractor feels it has no contractual obligation to address Company comments. Contractor also indicated that it does not have the resources to respond to Company comments, which is a default of Article 5.1. These recent statements made by Contractor are entirely contradictory to Contractor's commitments made in its letter to Company dated 12-Jul-2016 (LTR-CD0502-AG-LTCLILLP-0219).

Company reminds Contractor that it has an obligation to submit monthly progress reports in accordance with section 3.2.3 of Exhibit 3 – Coordination Procedures. Company also reminds Contractor that monthly progress reports are revision controlled documents and are required in accordance with SDRL Code A06 of Exhibit 4 – Supplier Document Requirements List. Company has the right to review Contractor's monthly progress reports and provide comments where Contractor had not complied with the Agreement. Subsequently, Contractor has an obligation to revise and resubmit the reports such that the reports are accurate and complete and meet the requirements of the Agreement.

Contractor's continued refusal to submit timely, accurate, and compliant monthly progress reports is inconsistent with Contractor's obligations under the Agreement. Company will consider all options to enforce its rights under the Agreement to ensure contractual compliance. To avoid further penalties (in addition to money already withheld for project management fees), Contractor shall promptly submit all outstanding monthly reports for Company's review.
