Re:	Summary of Management Outlook Cost Decks Located in Response to a Request from Inquiry Counsel

<u>Purpose:</u> In my interview on March 13, 2019, Inquiry Counsel Kate O'Brien asked me about the Management Outlook briefing decks provided to Grant Thornton by Paul Harrington. Ms. O'Brien indicated that Paul Harrington stated the cost and schedule information in those Briefing Decks was provided by the Project Controls Team. Although I did not become the Project Controls Manager until June 2016, and was not Project Controls Manager when the 2013, 2014 and 2015 Management Outlooks were produced, I was asked to locate the detailed backup. The following is what I have located in the project folders with respect to cost information.

<u>Findings:</u> Through discussions with the Lead Cost Controller, George Chehab, I understand that starting in June 2013 and continuing through Sept 2015, there were Management Outlook cost files prepared on a regular basis. In addition to the regular monthly cost reporting on awarded packages, the Management Outlook cost files included confidential information on packages for which bids were received (evaluation ongoing), as well as potentials for future bid packages based upon then current trends. In contrast to the regular monthly cost reports which were reviewed by the entire Project Management Team, the Management Outlook cost files were reviewed by a small group of Senior Management.

Following is a description of the files located, along with the FFC (Final Forecast Cost) noted in each file, as well as any meeting notices found related to the review of these packages. Where the files have been located by Nalcor counsel among those produced to the Inquiry or entered as exhibits the document or exhibit numbers are noted.
