Based upon a \$12.7B MF cost update this 36.1 cents per kwh

The 36.1 cents which is shown on page 7 of CA/KPL-Nalcor- 27 Rev. 1 is a levelized unit energy cost ("LUEC"). Nalcor does not compute the LUEC for the MF Project on an ongoing basis and therefore has no comparable LUEC for the \$12.7 billion cost update.

This letter will be published following a 72 hour period after it is sent electronically to you or five business days in the case where the letter has been mailed to you.

You may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the *Access to Information and Protection of Privacy Act* (the

Act) (a copy of this section of the Act has been enclosed for your reference). A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. Your appeal should identify your concerns with the request and why you are submitting the appeal.


