Your request for access to information under Part II of the Access to Information and Protection of Privacy Act, 2015 (File #: PB/947/2018)

On December 15, 2018, Nalcor Energy received your request for access to the following records:

"Emergency response times to restore the line to normal operating conditions are very difficult to predict due to the remoteness of the TL and levels of failure possible Outage periods of up to one month or greater in remote line sections are possible"

"MHI continues to support selecting a 1:150 year climatic return period due to the critically of the HVdc TL to the NL electrical system"

" Nalcor in the interest of minimizing overall cost to the customer has opted to apply load rotation and other means to minimize the overall impact to customers should an event occur "

Approx 70 % power demand is on the Avalon

After retirement of generation on the Avalon Peninsula including the Holyrood Thermal Generating Station and the Hardwoods Gas turbine power backup is needed for the Avalon

Provide copies reports re backup power supply plans for the Avalon (------in LIL outages (one month or more possible in remote areas) from 2 year prior to MF sanction up to the present

Regarding your request generally, there are no reports specifically addressing additional back-up supply to replace Holyrood on the Avalon for a LIL bi-pole contingency event. There is however documentation available which is responsive to your request, some of which is provided and some of which is publically available as indicated below.

Your appeal should identify your concerns with the request and why you are submitting the appeal.
