Re: CH0007 – Powerhouse, Spillway and Transition Dams Commercial Discussions – Without Prejudice

We understand from our meeting in St. John's earlier this month that Astaldi wishes to pursue discussions regarding commercial issues faced by Astaldi in the performance of Contract CH0007.

A key principle that we have consistently emphasized is that there must be valid contractual justification for any incremental compensation. This has been reinforced in recent discussions with our shareholder. Therefore, in order for Muskrat Falls Corporation to pursue further discussions, Astaldi must provide its position in writing that sets out in detail the contractual basis for additional compensation. For the avoidance of doubt, Muskrat Falls Corporation has not seen any evidence of contractual entitlement.

In the event that Astaldi wishes to pursue further discussions, Muskrat Falls Corporation requires, on a without prejudice basis, written, detailed rationale for each area that Astaldi believes additional compensation should be due, including the financial value of each and the relevant aspects of the contract. In addition, please fully disclose and individually quantify all underlying causes of increases in cost under the contract.

In parallel to these efforts we are pleased that there is continued cooperation in the field between our respective teams and we look forward to a safe and successful 2016 construction season.
