That money, as the Minister claimed was necessary as *Nalcor had run out of money* weeks ahead of the release of the Decision Gate Three (DG3) numbers.

"The Premier had repeatedly told the public her Government would not transfer funds to Nalcor unless the Muskrat Falls project was sanctioned, yet this week we finally heard of this secret transfer of millions of dollars almost two months after the transfer occurred," said Ball. "It shows just how little we can actually stake on commitments made by this Premier." The Premier and her caucus have been moving ahead without regulatory oversight of the Muskrat Falls project and giving theoretical sanction to a project which has not been properly vetted by sources outside of Government's own choosing.
