### Filibuster only option for dreadful Muskrat Falls legislation

Liberal Leader Dwight Ball is so disappointed with the enabling legislation for the Muskrat Falls project that the Official Opposition is left with no choice but to filibuster.

"Government is attempting to remove the Public Utilities Board (PUB) from having anything to do with the Muskrat Falls project," said Ball. "Additionally, they are enshrining Nalcor as a monopoly for providing industrial power."

Ball noted that Bill 60, *An Act Respecting the use and Expropriation of Land for the Purpose of the Muskrat Falls Project* and Bill 61, *Electrical Power Control Act, 1994, The Energy Corporation Act and the Hydro Corporation Act, 2007* were finalized by Government on December 7 and November 29, respectively, but were not provided to the Opposition until late yesterday morning.

"Government sat on this legislation for two weeks and now they are trying to rush it through the House of Assembly," said Ball. "The last time Government did that with an expropriation bill, they ended up with over \$100 million in environmental liabilities and an old Abitibi mill."

"Since the Premier was the lead on the botched Abitibi expropriation, it's shocking that she didn't learn from her mistakes," said Ball. "We cannot allow Government to rush this important legislation through the Legislature without proper due diligence, hoping the public won't notice. We're left with no choice but to filibuster."
