Ball noted that the language in the federal loan guarantee is clear that the Maritime Link to Nova Scotia has to be included in order for the Muskrat Falls project to benefit from the billion dollar loan guarantee signed between Emera, Nalcor and the federal government.

Back in December when Muskrat Falls was sanctioned just weeks after the signing of the loan guarantee the Opposition questioned if sanctioning was premature. Ball noted it's now evident that this is indeed the case given the new information coming out of the UARB hearings. "Furthermore, a lawyer for the Government of Nova Scotia told the UARB that the loan guarantee may also not be available for a "reimagined version" of the link or any other project.
