Liberal Energy Critic Dwight Ball says that by giving Emera of Nova Scotia the Right of First Refusal on excess Muskrat Falls power, the Dunderdale Government is breaking a commitment to the people of Newfoundland and Labrador and walking away from industrial development in our province.

“One of the main Tory talking points during the debate on Muskrat Falls was the ability to use 40% of the power for industrial development in our province, specifically Labrador. In fact, the Premier, her Ministers and PC backbenchers repeatedly said in the House of Assembly that 40% of Muskrat Falls power would be used for industrial development in our province,” said Ball. “However, after making this promise, the Premier and her PC colleagues have instead decided to give Emera of Nova Scotia all of the excess Muskrat Falls power.”

Ball noted that aside from the loss of power for industrial development, the fact the residents of Newfoundland and Labrador will have to further subsidize power rates in Nova Scotia is a tough pill to swallow.
